- 4. **SET-UP TIME** Arrival at the studio is no earlier than 15 minutes prior to the booking time. Set-up time is charged at R250 per 30minutes. Set-up time **EXCLUDES** the use of the white infinity curve wall for photos.
- 5. **OVERTIME IN STUDIO** If you wish to stay in studio longer than **15 Minutes** after your booking time has ended, overtime will be charged at R500.00 per hour.
- 6. **Payment Terms:** A 50% NON-REFUNDABLE deposit is required to confirm any booking of L-Create Studios. Bookings are made on a strictly first-come-first-served basis. Dates will ONLY be secured upon receipt of the deposit.
